Legacy Professionals provides audit, accounting and tax services to employee benefit plans, labor organizations, nonprofit organizations, gov-

ernmental entities, medium-sized corporations, partnerships and sole proprietorships, according to information provided by the firm. With headquarters in Westchester. Legacy also has offices in Schererville, Indiana and Edina, Minnesota, The company has about 150 employees, including 28 partners and principals, almost all of whom joined Legacy right out of college, said Timothy Cibulka, the firm's managing partner.

"We're excited to bring Tim into the partnership," Cibulka said. "He's a great asset to our firm."

Joining their ranks is a milestone and realization of a what feels like a lifetime goal, Fagan said.

"I've been here for 15 years, and I've been working for this accomplishment for 15 years," he said, noting he started with Legacy in January, so the promotion fell right on his 15-year anniversary. "It feels somewhat similar to when I passed the CPA exam. It's very satisfying and rewarding. I'm really thankful and humbled."

Fagan is an office reviewer and audit partner at Legacy. In terms of audits, he is focused on employee benefit plans, labor unions, nonprofits, small businesses and

Fagan said becoming partner would not have been possible without his wife, Christine, with whom he has two sons, Michael, 5, and Sean, 2.

"It could never have been done without my wife's work, her taking such good care of my family and me," he said. "My family and kids are by far the most important thing to me. They are my drive."
